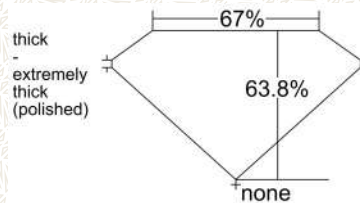

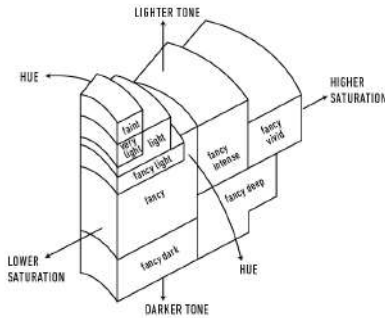
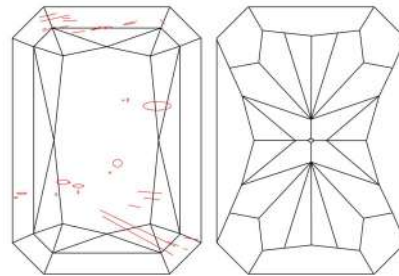


Illustration of GIA fancy color grade interrelationships

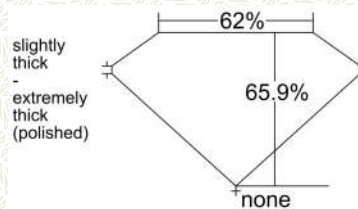

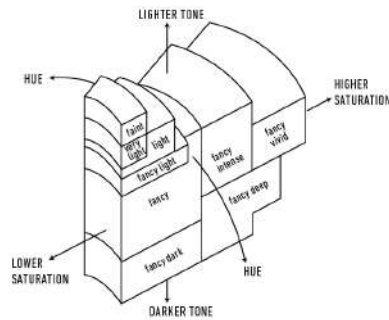
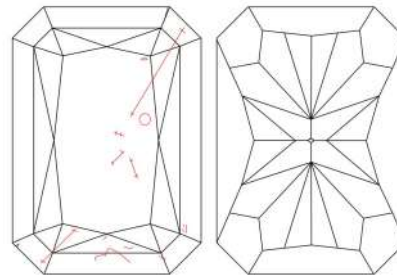


Illustration of GIA fancy color grade interrelationships
